Quarantine measures for travellers arriving from overseas during the pandemic of COVID-19

Due to the current COVID-19 situation in Sri Lanka and globally, following quarantine measures are imposed for travellers arriving in Sri Lanka.

My letter No. **DGHS/COVID-19/347/2021 dated 15.07.2021** on Quarantine measures for travellers arriving from overseas during the pandemic of COVID-19 **is hereby cancelled.**

Following sections are **amendments** to my letter No. **DGHS/COVID-19/347/2021 dated 07-07-2021** on Quarantine measures for travellers arriving from overseas during the pandemic of COVID-19.

1. Amendment to "Section C" in the letter No. DGHS/COVID-19/347/2021 dated 07-07-2021 on Pre departure negative COVID-19 PCR test report

All travellers of **two years and above** arriving in Sri Lanka should mandatorily carry a negative **COVID-19 PCR test report** in English language done **within 72 hours prior to embarkation.**

Note: Pre departure COVID-19 Rapid Antigen test report is not accepted

2. Amendment to "Section H.4.6" in the letter No. DGHS/COVID-19/347/2021 dated 07-07-2021 on Day Seven PCR test for Fully Vaccinated* travellers with negative On Arrival PCR reports

H.4.6.1 Fully vaccinated travellers who have **NOT arrived from/ transited at India or a travel restricted country** (mentioned below in **Section J.2**) and released from quarantine with an **On Arrival (Day One) negative COVID-19 PCR report, do not have to undergo COVID-19 PCR test on Day Seven.**

Unvaccinated children of **two years to eighteen years** who have been released with the fully vaccinated parents **should undergo a COVID-19 PCR test on Day Seven** after arriving in Sri Lanka from a Ministry of Health approved Private Sector or State Sector Laboratory. Day Seven PCR test results should be immediately informed to the area Medical Officer of Health (MOH) by telephone or email

3. Inclusion of "Section H.5" to the letter No. DGHS/COVID-19/347/2021 dated 07-07-2021

H.5 Quarantine Measures for Travellers with a past history of COVID-19

H.5.1 Travellers with a past history of COVID-19 should fulfill the following criteria

- H.5.1.1** Travellers with a past history of COVID-19 infection should have a valid document certifying COVID-19 illness (in English). The traveler should depart between the 28th to the 90th day from the date of positive COVID-19 Nucleic Acid Amplification Test (NAAT) **. This certificate should contain the name of the person, Dates and Names of the positive NAAT **. Such travellers should arrive after getting at least a single dose of Astra Zeneca/ Pfizer BioNTech/ Moderna/ Johnson & Johnson vaccine or any other single dose COVID-19 vaccine recommended for the general population to fully vaccinate them. This vaccine should be given during the period between two weeks after the positive NAAT** test and up to 14 days before departure.
- H.5.2** If fulfilled the criteria mentioned in Section H.5.1.1, they should be quarantined until **On Arrival (Day One) PCR test report is negative** report is available and NO further quarantine is necessary if the On Arrival (Day One) PCR test report is negative.
- H.5.3** In charge officer of the Quarantine Hotel / Centre or Hotel Doctor at Safe & Secure Certified Level 1 Hotel should discharge the traveller after verifying the status of vaccination and document certifying COVID-19 illness and issuing a "Discharge Document".
- H.5.4** When discharging travellers who fulfilled the criteria in Section H.5.1.1 after On Arrival (Day One) negative PCR report, In charge officer of the Quarantine Hotel / Quarantine Centre or Hotel Doctor at Safe & Secure Certified Level 1 Hotel should issue a "Discharge Document" and email the details to the Epidemiology Unit (chepid@sltnet.lk and samithag@hotmail.com) of the Ministry of Health.
- H.5.5** If there are **children below eighteen years**, they can be discharged with the parents **who fulfilled the criteria in Section H.5.1.1** by adhering to following measures:
- Children of **two to eighteen years** should be subjected to an on arrival (Day One) PCR testing and they should have negative results.
 - Children **below two years** will not be subjected to PCR testing after arrival to Sri Lanka and they will be discharged with the parents. However, if the on arrival (Day One) PCR testing of an accompanying traveller of the child is positive for COVID-19, child below two years will also be subjected to PCR testing subsequently.
- H.5.6** Should arrange their own transport to travel to residence / home and should not use public transport for this purpose.
- Throughout the travelling, they should strictly adhere to COVID-19 preventive measures imposed by Government of Sri Lanka.
- Driver and the passengers of the vehicle should properly wear a facemask throughout.
- Should travel directly to the destination without any stopovers.
- H.5.7** Unvaccinated children of **two years to eighteen years** who have been released with the parents **should undergo a COVID-19 PCR test on Day Seven** after arriving in Sri Lanka from a Ministry of Health approved Private Sector or State Sector Laboratory. Day Seven PCR test results should be immediately informed to the area Medical Officer of Health (MOH) by telephone or email

4. Amendment to "Section J" in the letter No. DGHS/COVID-19/347/2021 dated 07-07-2021

J. 1 Travellers arriving from India

J.1.1 Approval to arrive from India

- J.1.1.1 All Sri Lankans and their **accompanying** foreign National Spouse, children, Dual Citizens (if using the Sri Lankan passport to arrive) with a **travel history (including transit) in the past 14 days** to India, do not need to get the prior approval from the Foreign Ministry and Civil Aviation Authority of Sri Lanka to disembark in Sri Lanka. They have to liaise with the airline and arrive in Sri Lanka.
- J.1.1.2 All Foreign Nationals (including valid resident visa holders) and Dual Citizens (If using the foreign passport to arrive) with a **travel history (including transit) in the past 14 days** to India **will be permitted to disembark in Sri Lanka after getting the permission of Foreign Ministry (entry.permission@mfa.gov.lk) followed by Civil Aviation Authority (caaspax@caa.lk) of Sri Lanka.**

J.1.2 Quarantine Measures after arriving in Sri Lanka from India

J.1.3 If travellers arriving from India complete the two weeks period of recommended doses of vaccination **within first ten days** during their stay at Quarantine Hotel / Quarantine Centre/ approved quarantine residence, could be released from quarantine only after obtaining the negative Day One and Day Ten PCR reports.

If they complete the two weeks period after ten days of arrival in Sri Lanka, exit PCR should be done after completing two weeks from the last date of vaccination. Their unvaccinated children below 18 years can be released with the parents. Children of 2 years up to 18 years should be subjected to exit PCR tests on similar dates as their parents' and should have negative reports. They shall not be quarantined further after releasing from quarantine.

J.1.4 In charge officer of the Government managed Quarantine Hotel / Centre should issue a "Discharge Document" and email the details to the Epidemiology Unit (chepid@sltnet.lk and samithag@hotmail.com) if releasing Sri Lankan Citizens/ Dual

Citizens / valid resident visa holders who have been "Fully Vaccinated" / past history of COVID 19 illness with at least a single dose vaccine detailed above in Section H.5.1.1, arriving from India for home quarantine after **Day One** negative report, if they have a residence/ home in Sri Lanka to quarantine.

- J.1.5** Sri Lankan Citizens/ Dual Citizens / valid resident visa holders from India if approved to undergo quarantine at home/ residence, should immediately inform the area Medical Officer of Health (MOH) by telephone or email, soon after their arrival to residence / home. They should inform the results of **Day Ten** PCR report to area Medical Officer of Health.

J.2 Travellers from Travel restricted countries

Following countries are named as Travel Restricted Countries:

South American countries and South African countries (South Africa, Angola, Botswana, Lesotho, Mozambique, Namibia, Swaziland, Zambia, Zimbabwe).

- J.2.1** Following categories of travellers are allowed to disembark in Sri Lanka **if arriving from or transited at travel restricted countries** mentioned in **Section J.2 with the permission** of the Director General of Health Services/ Ministry of Health (dghs@health.gov.lk), followed by the permission of Foreign Ministry (entry.permission@mfa.gov.lk) and Civil Aviation Authority (caaspax@caa.lk) of Sri Lanka.

- a) Sri Lankan Citizens (and their Foreign National Spouses/ children)
- b) Dual Citizens (and their Foreign National Spouses/ children)
- c) Valid Resident Visa Holders (and their Foreign National Spouses/ children)
- d) Foreign national staff members of the diplomatic missions or UN organizations / UN Specialized agencies / International Organizations **with permanent offices in Sri Lanka** who are holding Diplomatic/UN/Official passports (mentioned in Annex 01 in my letter No. DGHS/COVID-19/347/2021 dated 07-07-2021 on Quarantine measures for travellers arriving from overseas during the pandemic of COVID-19) and their accompanying spouse, parents, and children
- e) Foreign Nationals arriving for important government projects / government meetings / discussions as invited by the **Sri Lankan Government**.

Following details need to be submitted when requesting the approvals to arrive from travel restricted countries:

- Sri Lankan Citizens (and their Foreign National Spouses/ children)/ Dual Citizens (and their Foreign National Spouses/ children) should submit the copies of their passports, marriage certificate if foreign national spouse is arriving, birth certificates of children.
- Resident Visa Holder (and their Foreign National Spouses/ children) should submit a copy of the passport, copy of the valid resident visa, marriage certificates if foreign national spouse is arriving, birth certificates of children.
- Foreign National staff member of diplomatic missions or UN organizations / UN Specialized agencies / International Organizations with permanent offices in Sri Lanka and their accompanying spouse, parents, and children should submit copies of the passports and copy of the Official Identity Card of the staff member.
- Inviting **Sri Lankan Government counterpart** should submit the details including the reason for inviting with a copy of passport if Foreign Nationals arriving for important projects / meetings / discussions

- J.2.2** All Sri Lankan Citizens (and their Foreign National Spouse/ children), Dual Citizens (and their Foreign National Spouse/ children) who have been granted approval to arrive from travel restricted countries have to undergo **mandatory Institutional Quarantine (irrespective of their vaccination status) at a Quarantine Hotel / Quarantine Centre (Centre: only if facilities are available to separate from travellers arriving from other countries)** and will be released from institution al

quarantine only after obtaining a negative PCR report done on Day 14 of arrival in Sri Lanka.

They shall **NOT** be quarantined at a Safe & Secure Certified Level One Hotel.

- J.2.3** All Foreign Nationals who have been granted approval to arrive from travel restricted countries have to undergo **mandatory Institutional Quarantine (irrespective of their vaccination status) at a Quarantine Hotel** and will be released from institutional quarantine only after obtaining a negative PCR report done on Day 14 of arrival in Sri Lanka.

They shall **NOT be quarantined at a Safe & Secure Certified Level One Hotel, Quarantine Centre or at a Residence.**

*If the recommended doses of the COVID-19 vaccination are completed and departs from abroad two weeks after completion of vaccination, they will be considered as "Fully Vaccinated".

****A Nucleic Acid Amplification Test, or NAAT**, is a type of viral diagnostic test for SARS-CoV-2, the virus that causes COVID-19. NAATs detect genetic material (nucleic acids). NAATs for SARS-CoV-2 specifically identify the RNA (ribonucleic acid) sequences that comprise the genetic material of the virus. NAATs can use many different methods to amplify nucleic acids and detect the virus, including:

- Reverse transcription polymerase chain reaction (**RT-PCR**)
- Isothermal amplification including:
 - Nicking endonuclease amplification reaction (**NEAR**)
 - Transcription mediated amplification (**TMA**)
 - Loop-mediated isothermal amplification (**LAMP**)
 - Helicase-dependent amplification (**HDA**)
 - Clustered regularly interspaced short palindromic repeats (**CRISPR**)
 - Strand displacement amplification (**SDA**)

This guideline will be revised depending on the COVID-19 situation in the country or the global situation.

The above **amendments** to my letter No. DGHS/COVID-19/347/2021 dated 07-07-2021 on Quarantine measures for travellers arriving from overseas during the pandemic of COVID-19 are **effective for the travellers arriving in Sri Lanka from 00:00 on 12th of August 2021 and travellers who have already arrived in Sri Lanka.**
